

# Camp Culbreath

---

## Generation 1

**CAMP CULBREATH** was born on 03 Feb 1791 in Mecklenburg County, Virginia. Camp or Kemp Culbreth served in the 6<sup>th</sup> Regiment of the Virginia Militia in the War of 1812. He married **MARY "POLLY" MCNEILL**, daughter of "Sailor" Hector McNeill and Mary (Last Name Unknown, although one theory that has been given to me by amateur genealogists is that she could have been a Culbreth) on 06 Aug 1816 in Robeson County, North Carolina. She was born on 15 Mar 1788 in Robeson County, North Carolina. In November of 1833, "Kemp" appears in the Robeson County Court Minutes, in the first of several appearances against Major and Rhoda Locklear resulting in a levy on lands in 1835. In 1837, Camp paid \$300 for 5 tracts of land in Southwest Bear Swamp in Robeson County, from Mary McNeill's brother, Malcolm Culbreth McNeill (b. 1781 –d. 1839). In 1838, he purchased an additional 1015 acres from William Townsend in Bear Swamp. Another piece of land containing 580 acres was purchased from Archibald McKay in 1850.

### Note:

The 1850 US Census indicates that Camp Culbreath could neither read nor write.

Camp Culbreath does not appear exactly as such in the records of Mecklenburg County, Virginia. However, there is a George Camp Culbreath who does match Camp's age and military service. It can be theorized that Camp dropped the "George" after leaving Virginia.

Mary McNeill died on 26 Jan 1877 in Robeson County, North Carolina. Camp died on 11 Jun 1856 in Lumberton, Robeson, NC.

Camp Culbreath and Mary "Polly" McNeill had the following children:

- i. **THOMAS CULBRETH** was born on 05 May 1817 in Lowe, Robeson County, North Carolina. He died on 19 Sep 1892 in Robeson County, North Carolina. He married Anne Elizabeth Peabody, daughter of Nathaniel Prentice Peabody and Lydia Dusenbury Salmon, on 09 May 1855 in Robeson County, North Carolina. She was born on 25 Aug 1828 in Bennettsville, South Carolina. She died on 19 Apr 1893 in Robeson County, North Carolina.
- ii. **JAMES CULBRETH** was born on 15 Feb 1822 in Lowe, Robeson County, NC. He died on 10 Feb 1900 in Gaddys Mill, Marion County, SC. He married Penelope Jane Thompson, daughter of Jacob Alford Thompson and Sarah Williams, on 21 Mar 1849 in Robeson, NC. She was born on 15 Nov 1829 in Robeson County, North Carolina. She died on 30 Jan 1909 in Gaddys Mill, Marion County, South Carolina.
- iii. **MARY CULBRETH** was born on 25 Oct 1825 in Lowe, Robeson County, NC. She died on 22 Jun 1900 in Robeson County, North Carolina.
- iv. **MALCOLM CULBRETH** was born on 20 Aug 1826 in Robeson County. He died on 22 Feb 1864 in Smithville, Brunswick, North Carolina.
- v. **LUCY CULBRETH** was born on 30 Jul 1828 in Lowe, Robeson, NC. She died on 13 Mar 1854 in Robeson, NC.

## Camp Culbreath and the Culbreaths of Southside Virginia

---

The history of Camp Culbreath, and the Culbreath history in Mecklenburg County, Virginia, is murky at best.

Popular tradition holds that our family's arrival in the New World can be traced to three Culbreth brothers arrived in Philadelphia from Scotland and traveled south along the coast settling in Mecklenburg County (then Lunenburg County), Virginia. Culbreths and their variants (Colbreath, Coolbreath, Calbreath, Colebreath, etc.) are found throughout the records of Lunenburg and Mecklenburg Counties in Virginia, and adjacent Granville County, North Carolina. In addition to the tax and census records, the family appears in court records as well.

The Culbreaths arrived in Southside Virginia around 1748. In 1753, deeds from the area show a large division of 3070 acres owned by men William Morris, Drury Stith, and Michael Cadet Young. The land was divided on one day to Edward, Peter, William, and John Culbreath along with Archibald Clark, John Mayes, John Tabor, Owen Franklin, Johnathan Richardson, Patrick Frail, and Daniel and Malcolm McNeill. Much of this land was submerged in 1952 in the flooding of the Roanoke River forming Kerr Lake.

Professional genealogists hired by members of the family have confirmed that Camp Culbreath's father was:

THOMAS CULBREATH, who was born in 1761 in Mecklenburg County, Virginia. He died in 1822 in Mecklenburg County, Virginia. He married LUCY CAMP. She was born in 1748 in Virginia. She died after 1796. LUCY CAMP first married WILLIAM CAVINESS, son of Henry Caviness and Jane Allen, in 1770 in Mecklenburg County, Virginia. He was born in 1741 in Mecklenburg County, Virginia. He died in Jun 1775 in Mecklenburg County, Virginia. Two children from the Camp-Caviness marriage were JOHN CAMP CAVINESS and WILLIAM CAVINESS. These two sons were taken under the guardianship of THOMAS CULBREATH in 1775. Interestingly enough, the WILLIAM CAVINESS married ELIZABETH CULBREATH on 08 Feb 1796. She was about 16 years old. Her relation is unknown. Most likely they were cousins by marriage.

There is also recorded in Marriage of Mecklenburg County from 1765 to 1810, that THOMAS CULBREATH married POLLEY CULBREATH, on 8 May 1809.

Furthermore, THOMAS CULBREATH's father was:

WILLIAM CULBREATH. He married MARGARET CAMP in Virginia. She was born in 1730 in Mecklenburg County, Virginia. He died on 28 May 1787 in Mecklenburg County, Virginia. She died after 1787 in Mecklenburg County, Virginia.

WILLIAM CULBREATH was by far the wealthiest of the Culbreaths in the Southside. In 1787, tax records indicate he owned 15 slaves and almost 65 head of cattle.

It is supposed that WILLIAM CULBREATH's parents (or grandparent(s)) were Edward Culbreath(s), and a woman named Affa.

The Culbreaths are gone no longer in Virginia by 1820-1830. The descendents of these Culbreaths from the Southside of Virginia moved to Columbia County, Georgia; Rutherford County, North Carolina, Tippah County, Mississippi, Smith and Tipton Counties, Tennessee, and finally Robeson County, North Carolina.

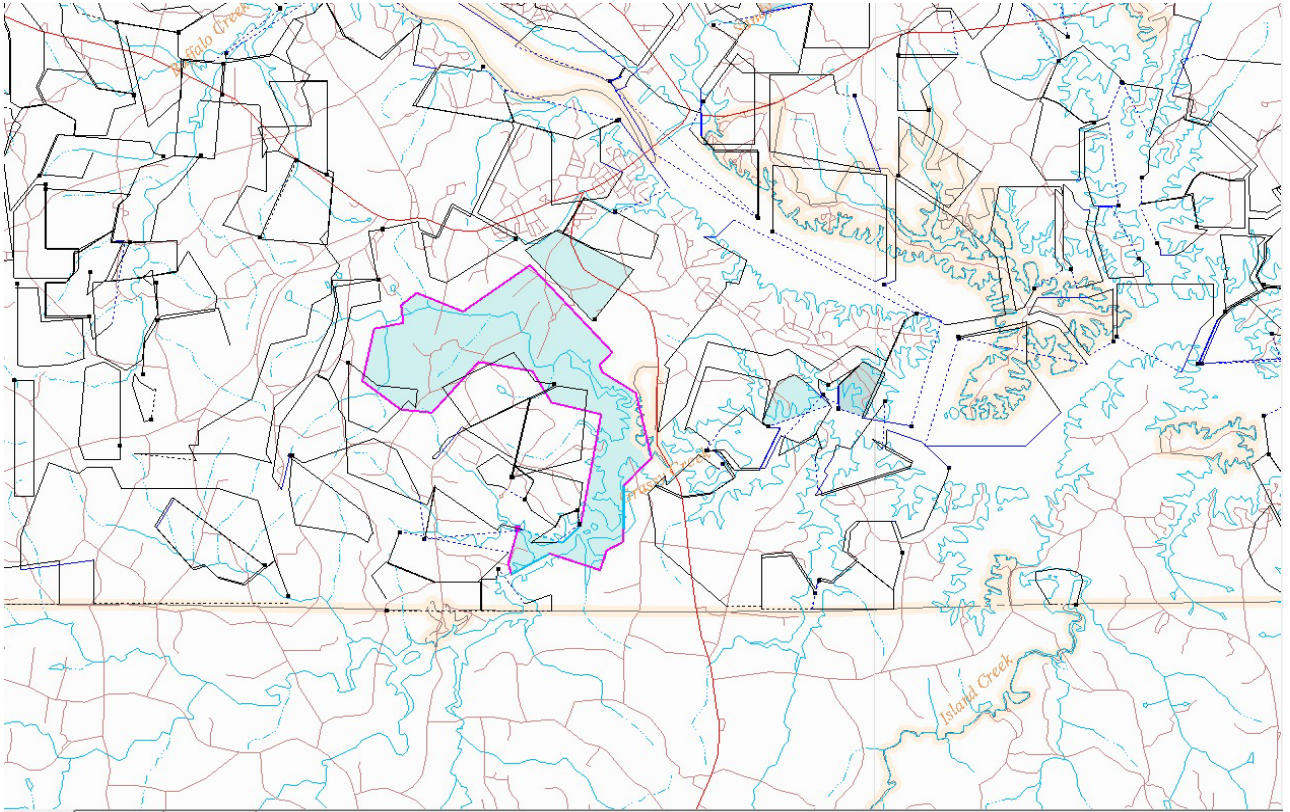


Figure 1: Map of Culbreth land in Mecklenburg Virginia in late 18th Century

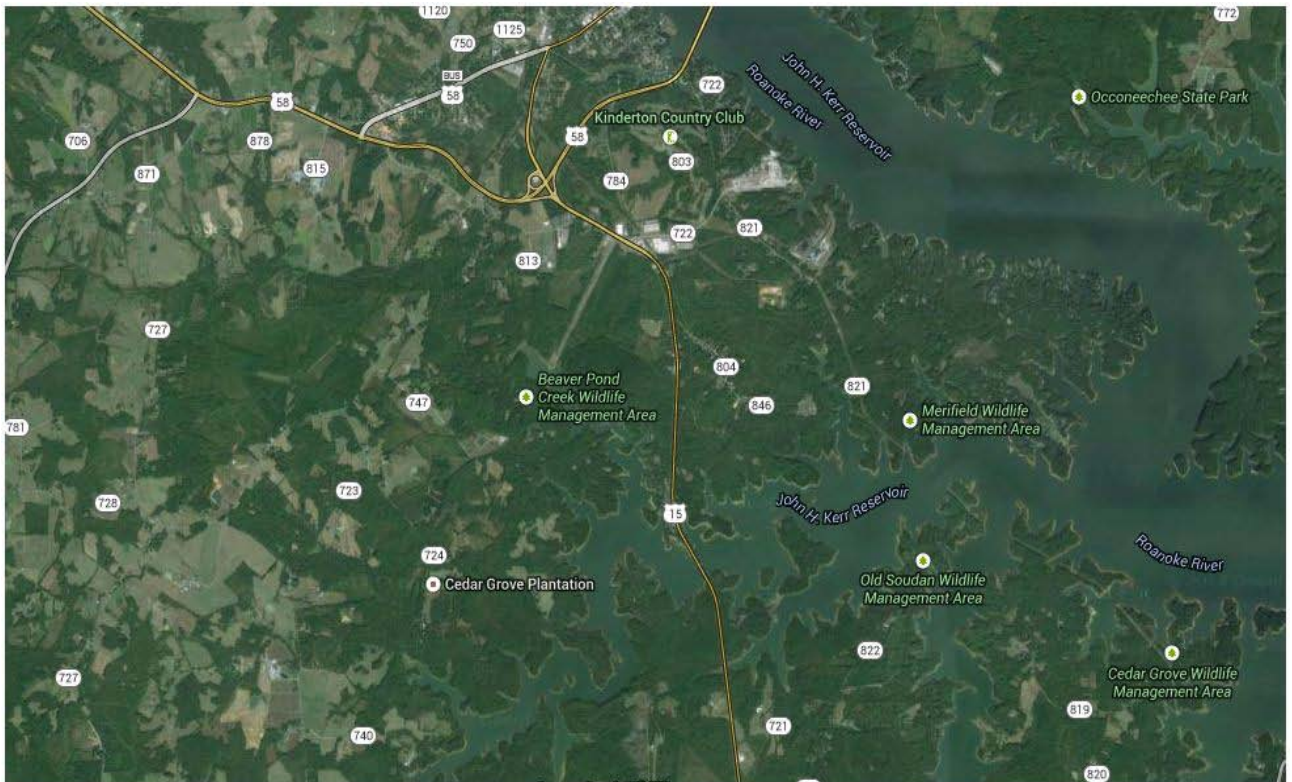


Figure 2: Map of Mecklenburg County, Virginia 2015

## Who was Mary McNeill and “Sailor Hector”?

---

Mary “Polly” McNeill was the daughter of “Sailor Hector” McNeill. McNeill family tradition holds that "Sailor Hector" and his brother "Shoemaker John" were young boys when their father, Neill McNeill, immigrated to North Carolina in 1740.

It is most likely, though not certain, that Neill McNeill and his two sons arrived in North Carolina with the Argyll Colony. The Argyll Colony was the first colony of Highland Scots to settle in the Upper Cape Fear. Settled in 1739, the colony was named for the region in western Scotland from which its members came. The Highland colonists moved up the Cape Fear River eventually settling in Campbeltown and Cross Creek (what would eventually become Fayetteville, North Carolina). As more and more Scots came into the region, they moved into surrounding areas of what would become Hoke, Moore, Robeson, Richmond, and Scotland Counties. By the 1770s Highland Scots comprised one-third of the population of that region, appropriately earning the region the moniker "Valley of the Scots."<sup>i</sup>

It has been said also that Sailor Hector got his nickname during the American Revolution but documents indicate he was using "Sailor" with his name in the 1771 Bladen County tax list, living with his father Neill McNeill. It is likely then that this is a name he earned in the French Indian War, or due to his sailing prowess in general. "Sailor Hector" settled just south of Sizemore Branch (the stream that bisects the property where Red Springs High School is located) in Red Springs on the hill stood near the McNeill cemetery in town<sup>ii</sup>.

Mary McNeill Culbreth was for a time the matriarch of the Culbreth clan. After the passing of Camp, she lived in the care of (iii) MARY CULBRETH and (iv) MALCOLM CULBRETH<sup>iii</sup>.

In the home next door was (i) THOMAS CULBRETH. Brother (ii) JAMES CULBRETH, was living in Marion County, South Carolina.

In the name of God Amen, I Samp  
Culbreath of the State of North Carolina  
and County of Robeson being of sound mind  
mind and memory (Blessed be God) do this  
Thirteenth day of February in the year of our  
Lord One Thousand Eight Hundred and Fifty  
Six, make and publish this my last Will  
and Testament in manner following to wit

1st I give and bequeath to my beloved wife  
Mary Culbreath Four Hundred Acres of  
Land whereon I now live two Sorel Horses  
all the Stock of Cattle Hogs & sheep all  
my household and Kitchen Furniture all  
all my Carts Carriages and gear and tools  
of every description except my Blacksmith  
tools all my present Stock of Corn Fodder  
and Bacon now on hand. Three negro women  
and their increase (to wit) Mirns Martha and  
Sophia, The above property I give to my  
wife Mary during her natural life and  
after her death I wish my son Thomas  
to have Mirns and Martha and their  
increase from this time. After the death  
of my wife I wish my Daughter <sup>Mary</sup> Culbreath  
to have all the property of every description  
both real and personal except that which I  
have given to my son Thomas Culbreath  
to him and her <sup>body</sup> heirs forever.

To my son Thomas Culbreath I give my  
Blacksmith tools and shot Gun and two  
negroes Amy and Emily and their increase  
to him and his heirs forever.

To my son Malcom Culbreath I give Six hundred  
Acres of Land more or less <sup>Beginning</sup> On the Bear swamp  
about two hundred and fifty yards below my  
House with the direction of Wm Sawsond's  
old Ditch and runs up said ditch to a sweet  
gum in or near the Ford of the first Branch  
cut by the Angus field, to William Sawsond's  
back line - and after the first mentioned  
four Hundred Acres is laid out and allotted  
to my wife Mary - the balance which may  
belong of my lands I wish my son Malcom Culbreath  
to have lying below bounded by Charles  
Sawsond and others after my death as soon  
as my son Malcom Culbreath prepares  
a place for them I wish him to have two  
Negroes (to wit) Dick and Anna to him and  
his heirs forever.

To my son James Culbreath I give two Negroes  
Easter and Jerry and at the death of my  
wife I give him another boy by the name  
of Sam to him and his heirs forever.

To my daughter <sup>Mary</sup> Culbreath I give One Bay mare  
about four years old to her and her heirs forever.  
And I hereby make and ordain my friend  
John Moore and my son Thomas Culbreath  
Executors to this my last Will and Testament.

In witness whereof I Camp Culbreath have hereunto  
set my hand & seal the day and date first written  
Signed Sealed published and declared by Camp Culbreath  
as his last Will and Testament in presence of us

In Robeson county, on the 12th inst., KEMP CULBREATH, aged 65 years and 6 months, leaving a wife and large family of children to mourn over their loss. He was raised in Mecklenburg, Va., but was a resident of the county of Rebeson, N. C., for the last forty years. He was a most worthy citizen, a kind and affectionate husband and father. He suffered a great deal of pain for the last six months, but bore it with christian fortitude and resignation to the will of his Divine Master and Saviour, and died rejoicing in Christ,—entreating his family and friends to prepare to meet him in that blissful abode where there is no sickness, no parting of friends, and no more death, but life everlasting in the presence of the Redeemer. He was a worthy and consistent member of the Presbyterian Church for twenty years back. Truly it may be said, a good man has gone hence to his home in Heaven, where the wicked cease from troubling and the weary are at rest.

## Mary, Malcolm, James and Lucy Culbreth

---

MARY CULBRETH was born on 25 Oct 1825 in Robeson County, NC. She died on 22 Jun 1900 in Robeson County, North Carolina. She was the daughter of Camp Culbreth and Mary McNeill. She never married, lived beside her brother Thomas, whom she outlived. She had numerous servants reflected in the census. She and her brother Malcolm lived with their mother, Mary Culbreth, from the 1850's onward. An amusing story about Mary can be found in the book "Descendents of Sailor Hector McNeill" by James M. Roberts, cited by Annie Culbreth Gaitley as told to her by her father William Kemp Culbreth. She cites that William Kemp lived with his aunt Mary Culbreth (confirmed in 1870 census) and "one time she had a tumor and her stomach was swollen. A family named Gregory lived next door and they started the rumor that Mary was pregnant. She would never have anything to do with any of the Gregory family after that. She always said that she was glad she lived and proved it was not true."

MALCOLM CULBRETH was born on 20 Aug 1826 in Robeson County. In 1861 he enlisted in the 40<sup>th</sup> North Carolina Regiment (3<sup>rd</sup> Artillery) Company E, which mustered troops from Robeson and Richmond Counties. The name of their unit was the "Scotch Greys," under the command of Capt. Malcolm McBryde. This unit was stationed at Fort Fisher outside of Wilmington, North Carolina. He died on 22 Feb 1864 in Smithville, Brunswick, North Carolina. The obituary in the Fayetteville Observer read: *Died, Feb. 22, 1864, of typhoid pneumonia, in hospital at Smithville, N.C., Malcolm Culbreth, in the 43rd year of his age. The deceased was born in Robeson Co., where he lived an exemplary life and an ornament to society until he felt it his duty to obey the call of his bleeding country, when he bid adieu to and left the embrace of weeping friends, determined never to sheathe his sword until freedom should be established. As his end drew near, his confidence in God remained unshaken, and he calmly sank to rest, pillowing his head upon the bosom of his blessed Savior. He leaves a mother, sister, and brother, and also a large circle of friends, to mourn his irreparable loss.*



JAMES CULBRETH was born on 15 Feb 1822 in Robeson County, NC. He graduated from South Carolina University Medical School in 1851. From there he moved to Marion County (now Dillon County) South Carolina where he practiced medicine. He was the only physician in the county during the Civil War. He married Penelope Jane Thompson, daughter of Jacob Alford Thompson and Sarah Williams, on 21 Mar 1849 in Robeson, NC. She was born on 15 Nov 1829 in Robeson County, North Carolina. She died on 30 Jan 1909 in Gaddys Mill, Marion County, South Carolina. James died on 10 Feb 1900 in Gaddys Mill, Marion County, SC. James Culbreth and Penelope Thompson had 11 children; they were:

- i. SUSAN CELESTE CULBRETH was born on 11 Mar 1850 in Marion County, South Carolina. She died on 25 Feb 1936 in Marion, South Carolina.
- ii. AGGENORA BINCHAM CULBRETH was born on 02 Jan 1852 in Marion County, South Carolina. She died on 16 Aug 1863.
- iii. MARSHALL MONTGOMERY CULBRETH was born on 02 Nov 1854 in Dillon, South Carolina, United States. He died on 07 Mar 1921 in Orrum, Robeson County, North Carolina. He married (1) MARY PHILLIPS on 12 Nov 1908. She was born in 1860 in Rowland, North Carolina. She died on 20 Jan 1938 in Gaddy, Robeson County, North Carolina. He married (2) MARGARET ELIZABETH WATSON on 26 Nov 1891. She was born on 11 Apr 1868 in South Carolina. She died on 28 Mar 1908 in South Carolina.
- iv. FRANKLIN DRAPER CULBRETH was born on 16 Jan 1857 in Marion Co., South Carolina. He died on 02 Feb 1946 in Asheboro, Randolph, North Carolina. He married Lena Jane White, daughter of Roderick McSwain White (Musselwhite) and Bertha Jane Powers, on 14 Feb 1912 in Robeson County, North Carolina. She was born on 28 Oct 1883 in Robeson County, North Carolina. She died on 11 Aug 1942 in Robeson County, North Carolina.
